- 2.4. The machines and tools must be handled and maintained with care and any wear, defects, damage or loss must be reported to the workshop management immediately. Infringements may lead to exclusion from the workshop. Negligent damage or theft of materials/equipment etc. must be financially compensated by the user or equivalent compensation must be provided.
- 2.5. Cancellation of a booked workshop must be notified to the management or workshop manager at least one day before the start of use. Otherwise the full workshop fee will be charged.

  - 5.4.2. The work tables and tools must be left clean.
  - 5.4.3. When leaving the rooms, switch off all lights and pull out all plugs.
  - 5.4.4. The heating must be turned down, all doors and windows must be closed.
